## Freedom of Information Request – FOI2024/00264

We are writing in response to your email received by Post Office Limited ("Post Office") on 5 February, which has been dealt with under the terms of the Freedom of Information Act 2000 ("FOIA"). We sincerely apologise for the delay in responding to your request.

In your email you have requested the information shown verbatim in bold below:

"I write regarding the Post Office Network Reinvention Scheme which took place between November 2002 and March 2005.

I would be grateful if you could share the guidelines which were used to decide a compensation offer for those sub-postmasters and postmistresses who had their offices closed, including the guidelines for those who had been running their offices for a short period of time."

Following an extensive search of our records, we can confirm that Post Office does not hold the information you have requested.

We carried out electronic searches across our records using the following terms: "Network reinvention", "Reinvention Scheme" and "Compensation", within the 2000-2005 period, which returned no results. We also searched using the term "Reinvention" which also did not return any results responsive to your request.

Finally, we also conducted a manual search of our scanned paper records, and were unable to find anything responsive to your request.

It is worth noting that Post Office separated from Royal Mail Group ("Royal Mail") on 1 April 2012, and therefore, we do not have access to information that may be held by Royal Mail.
