## Freedom of Information Request – FOI2024/01555

We are writing in response to your email received by Post Office Limited ("**Post Office**") on 30 November, which has been dealt with under the terms of the Freedom of Information Act 2000 ("**FOIA**").

In your email, you have requested the information shown verbatim in bold below:

I'm would like to request information regarding the usage figures of the postal redirection schemes. Specifically I would like to know how many users of the service there were during the periods of 1990 and every 5 years since if these figures are at all available.

This is out of pure curiosity with the rise of the internet and ability to update address details and phone numbers etc quicker than the old ways. If you have any questions please feel free to ask.

We can confirm that Post Office does not hold the information you have requested (i.e., "the usage figures" for the postal redirection scheme).

However, this information may be held by Royal Mail Group ("Royal Mail"), who provide the service. Post Office separated from Royal Mail on 1 April 2012 and, therefore, does not have access to information held by Royal Mail, including the requested information.

Please let us know if you would like us to consider whether this information can be disclosed under the FOIA.

If you are dissatisfied with the handling of this response, you do have a right to request an internal review.
