## Freedom of Information Request - FOI2025/00625

We are writing in response to your email received by Post Office Limited ("**Post Office**") on 2 September 2025, which has been dealt with under the terms of the Freedom of Information Act 2000 ("**FOIA**").

In your email, you have requested the information shown verbatim in bold below:

- "\* Please provide me with the number of limited companies who have received and accepted a payment following the Horizon Shortfall Scheme
- \* Please provide me with a table of awards paid in the following categories (for clarity 'K' is a thousand and 'M' is a million):
  - \* Less than £100k
  - \* £100k £199K
  - \* £200k £299K
  - \* £300K £399K
  - \* £400K £499K
  - \* £500k £599K
  - \* 600K £699K
  - \* £700K £799K
  - \* £800K £899K
  - \* £900K £999K
  - \* Above £1M"

We can confirm that Post Office does hold the information you have requested. We have interpreted your request to relate to those limited companies for which Post Office has settled a full and final payment, not limited companies who have received an offer and, in some cases, also received an interim payment whilst the claimant is considering the offer, or whilst the offer is being processed within the dispute resolution team.

Where there are fewer than 5 individuals in any payment amount bracket we have decided that the information should be withheld under sections 40(2) and 40(3A) of the FOIA, as the information constitutes personal data relating to other persons.

These sections exempt personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would breach any of the data protection principles in Article 5(1) of the UK General Data Protection Regulation ("GDPR").

We consider that disclosure of this information is likely to breach the first data protection principle, which provides that personal data must be processed lawfully, fairly, and in a transparent manner. Disclosure would not constitute 'fair' processing of the personal data because where there are fewer than 5 individuals in any payment bracket, there is a possibility of these individuals being identified.

In these cases "<5" is used to indicate that a figure between 1 and 5 is being suppressed.

Please note the amounts paid include, where applicable, tax top-ups and 75k top up values, although in some cases the tax top-up, or the £75k top-up may still be outstanding.

If you are dissatisfied with the handling of this response, you do have a right to request an internal review.
