## Freedom of Information Request - FOI2024/00706

We are writing in response to your email received by Post Office Limited ("**Post Office**") on 25 April, which has been dealt with under the terms of the Freedom of Information Act 2000 ("**FOIA**").

In your email you have requested the information shown verbatim in bold below:

"This is email is a formal Freedom of Information request for disclosure of amounts spent by Post Office Limited on fees with the following accounting and legal firms in the following periods:

A. Period of information requested - each of the financial years ending March 2000 to March 2023B. Firms with whom expenditure incurred by Post Office Limited:

1. Accountancy firms PWC (PriceWaterhouseCoopers) EY (Ernst & Young) KPMG Deloittes

2. Forensic accountants Second Sight

## 3. Solicitors Womble Bond Dickinson ( and previously as Bond Pearce and Bond Dickinson)"

Whilst we hold the information sought, we do not hold it in a readily accessible format and therefore in accordance with our duties under section 16 of the Act, we have provided the table in Annex 1 at the end of this letter, showing information from 2014 to 2023 that contains the total sums paid to each firm.

It is worth noting that Post Office and Royal Mail Group separated in 2012, and Post Office's finance system only holds information going back to 2014.
