Freedom of Information Request – FOI2024/00429

We are writing in response to your email received by Post Office Limited ("**Post Office**") on 14 March, which has been dealt with under the terms of the Freedom of Information Act 2000 ("**FOIA**").

In your email you have requested the information shown verbatim in bold below:

"For the year ending March 2023 could you please supply the following information, How many branches received pay of less than £1000, less than £5000, £10000, £150000, £200000, £50000, £60000, £70000, £100000. How many branches received more than £100000.Thank you"

Post Office has interpreted your request to mean the remuneration paid to Postmasters for the number of branches that have traded for the full 12 months of April 2022 to March 2023.

The information within the table below is the remuneration figures for a core FAD code, any outreach remuneration will be included within the Postmasters core FAD code. The table below includes Banking Hubs but does not include Drop and Collect Branches.

Under s.16 FOIA, Post Office would like to provide the following information to you to advise and assist you with our response to this request:

It is important to note that branch figure in our network report will not match the figure in this response for several reasons. The figure above is drawn from a system that organises payments to Postmasters and so it would only record one payment to a Postmaster, who may have more than one branch and who also may operate an outreach service that serves more than one area but under one branch code. Additionally, some Postmasters may be in receipt of fixed payments and subsidies. The figure also excludes those branches managed by strategic partners.

If you are dissatisfied with the handling of this response, you do have a right to request an internal review. You can do this by writing to the address above within 40 working days of receipt of this response stating your reasons for your internal review request or alternatively, by emailing <u>information.rights@postoffice.co.uk</u>.
