We are writing in response to your email received by Post Office Limited ("Post Office") on 10 June, which has been dealt with under the terms of the Freedom of Information Act 2000 ("FOIA"). We apologise for the delay in providing this response.

In your email, you have requested the information shown verbatim in bold below:

"Could you provide details of Speak Up reports regarding the culture within Post Office since 2019?

Could you also provide details of any staff surveys regarding the culture within Post Office since 2019."

We can confirm that Post Office does hold the information within scope of your request.

We have interpreted the term "details of Speak Up reports" to mean the numbers of complaints received by the Speak Up service since 2019. Given that all complaints to the Speak Up service may relate to the wider interpretation of 'culture' within Post Office, we are including the total number of complaints received by the Speak Up service during this time period.

Given that the Speak Up service is anonymous and complaints are made via an externally-publicised email address, we are unable to determine whether complaints

were made by internal employees or external parties, unless these individuals identified themselves in their complaint.

Please note, a dedicated Speak Up Team was only established in 2022, and whilst the service was available before that as a Whistleblowing service, we cannot be certain of the accuracy of the information we hold between 2019-2022.
