## Freedom of Information Request – FOI2025/00486

We are writing in response to your email received by Post Office Limited ("Post Office") on 9 July, which has been dealt with under the terms of the Freedom of Information Act 2000 ("FOIA").

In your email, you have requested the information shown verbatim in bold below:

"Please provide a copy of all directions given to the Post Office under section 11(3) of the Post Office Act 1969 along with any correspondence between the Post Office and the relevant government department that relates to the drafting and/or adoption of each direction.

If possible, I would like to receive the requested information electronically via email."

We can confirm that Post Office does not hold the information you have requested.

Section 11(3) of the Post Office Act 1969 was repealed by the Postal Services Act 2000, which came into force on 26 March 2001. Accordingly, we will not hold any ministerial Directions under section 11(3) of the Post Office Act 1969 which date from 26 March 2001 onwards.

In keeping with our data retention policies, copies of ministerial Directions which were received before this date are likely to have been deleted / destroyed. You may find it helpful to note that Post Office and Royal Mail were still one entity in 2001.

When the entities split, the majority of the historical records remained with Royal Mail and Post Office only took the records it needed to continue its business at that time.
