Please be kind enough to disclose the 3 above referenced Letters from Perm Secs to the CEOs of Post Office Limited."

We can confirm that Post Office does hold some of the information you have requested. Please find attached letter 1 "FOI2025\_00019-Letter from Alex Chisholm to Nick Read (signed 6 sept)\_Redacted" and letter 3 "FOI2025\_00019-190103\_Letter\_ACtoPV\_Redacted". Despite extensive searches we have been unable to locate letter 2 so this is information is not held.

A small amount of information has been withheld from letters 1 and 3 under sections 40(2) and 40(3A) of the FOIA as the information constitutes personal data relating to other persons. These sections exempt personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would breach any of the data protection principles in Article 5(1) of the UK General Data Protection Regulation ("GDPR").

We consider that disclosure of this information is likely to breach the first data protection principle, which provides that personal data must be processed lawfully, fairly, and in a transparent manner. Disclosure would not constitute 'fair' processing of the personal data because the individuals involved would not reasonably expect their contact details to be disclosed in relation to this request for information.

If you are dissatisfied with the handling of this response, you do have a right to request an internal review. You can do this by writing to the address above within 40 working days of receipt of this response stating your reasons for your internal review request or alternatively, by emailing <a href="mailto:information.rights@postoffice.co.uk">information.rights@postoffice.co.uk</a>.
