### **POST OFFICE CONVICTIONS AND COMPENSATION**

Thank you for your letter of 9 January regarding the Post Office convictions and compensation.

On Wednesday 10 January, the Prime Minister announced the Government will introduce primary legislation in the coming weeks to quash all convictions that were based on the erroneous Horizon evidence and/or the poor behaviour of the Post Office investigation and prosecution teams, behaviour you describe in your letter as 'abysmal'. This blanket exoneration will clear the names of post-masters and mistresses and make sure they can access the compensation they deserve as quickly as possible. Once this legislation is passed and convictions have been quashed, individuals will be entitled to at least £600,000 in compensation to rebuild their lives.

Fairness is at the heart of our justice system and there can be no doubt that innocent post-masters and mistresses have suffered an intolerable, exceptional and unprecedented miscarriage of justice at the hands of Post Office Ltd. These are truly exceptional circumstances, and we must right this wrong quickly, ensuring those convicted can be fairly and swiftly compensated.

This is why the Government has chosen to legislate for a blanket quashing of convictions, rather than doing so on a case-by-case basis. This necessarily means we will not be able to make an assessment of an individual's guilt or innocence. The Government therefore has to accept the risk that some postmasters who committed a crime will have their convictions overturned and will be eligible for compensation. The Government has concluded on the unique facts of this case that such a risk must be accepted to ensure timely justice for the many postmasters who have been so seriously wronged. The principle that underpins our decision is that of the great legal scholar Sir William Blackstone who said "better that ten guilty persons escape, than that one innocent suffer". That said, I and my officials are working with our colleagues in the Department for Business and Trade, who will own the forthcoming legislation, on potential ways to reduce the risk of fraudulent claims without putting unnecessary barriers in the way of genuine victims claiming compensation.

I am grateful for your ongoing support and for Peters & Peters continued engagement. I am aware that my officials are in touch with Post Office Ltd and appreciate the assistance your officials are providing.

A few other things to note:

- The last letter POL sent into DBT and MoJ on this issue was leaked to the FT. They described it as being a letter to DBT (when in fact it was addressed to the Lord Chancellor). This suggests that they hadn't seen the whole letter, only an extract, and that the leak may well have come from DBT. That letter wasn't marked as legally privileged when it was sent it. The handling of it in the department may well have been different if it had been (and therefore the handling of this might be if it were appropriately marked).

You'll have seen today that Ministers have announced a radical approach to convicted sub postmasters.
